

# 177 Receive State Farmer Degree at State Convention

177 members of the Florida Association, FFA, received the State Farmer Degree at the State Convention in Daytona Beach. The total labor income of these members from productive enterprises was \$449,724.87. Each received at least \$5 from the Mid-States Steel and Wire Company. The best in three districts received \$10, the best in two areas received \$25 and the Star State Farmer received \$50 from them. The State Farmer Keys were presented by eight Florida Production Credit Associations. The two area winners received \$100 from the Southern Nitrogen Company, Inc., Savannah, Georgia, and the Florida Nitrogen Company, Tampa, Florida; the District Winners received \$75.00 each, and the Adviser of the Star State Farmer received \$75, to help pay their expenses in attending the National FFA Convention in Kansas City next October. Three other outstanding members also received \$50.00 each and transportation to the National Convention from the State Department of Agriculture. Life is one continuous challenge. Evidently it wasn't intended to be all level and free of bumps. The hills make us push harder. The bumps keep us from





The sixth session was called to order by the President, David Brengle. He then introduced David King, 3rd Vice-President from Jasper who presided over the session.

















# **Boys Span Half-Continent** To Be At Brother's Funeral

Jim Busby, freshman at the University of Florida and son of Mr. and Mrs. Joe Busby was killed in an automobile accident north of Gainesville in April. He was an outstanding member of the Santa Fe FFA Chapter at Alachua.

Jim recorded the highest score ever made at Santa Fe on the Senior Placement Test. He received the State Farmer Degree and had won many scholarships to use to pay his way through college.

That Jim left a record of excellence and participation which his family and community are maintaining with gallant determination is illustrated in the news story reprinted here.

"The show must go on" is a timehonored tradition of show people.

Young Joe and Glen Busby are not "show people." They are members of the state champion land judging team of the Santa Fe High School FFA Chapter which took part in the national competition in Oklahoma City.

After making the long drive out to Oklahoma City, then flying back to Gainesville for the funeral of their older brother, James, the Busby boys-after another plane flight-rejoined the team yesterday, so that "the show" can go on and Florida will be represented in the national land judging event.

The Busby boys, along with their advisor, Kenneth Lee, and other team members, Donald Boggs and Lowell Parrish, left this past Saturday for Oklahoma City. On arrival in Oklahoma City, Joe and Glen received the tragic news that their brother, James, a former outstanding FFAer and student at Santa Fe, had been fatally injured in an automobile accident Saturday night.

The team, out of funds it had won for the Oklahoma City trip, advanced the fare for Joe and Glen's flight back to Gainesville for James' funeral, which was

According to F. D. McCormick, vo-ag teacher at Santa Fe, Joe and Glen and their father, Joe N. Busby, agreed that the boys should return to Oklahoma City, so that the land judging team would not be crippled.

With a goal of \$300, the people of the Santa Fe High School community set out to raise funds for the return flight. Santa Fe Principal L. B. Lindsey said \$340 was raised Tuesday afternoon. Then yesterday morning, Lindsey said, a bus driver from the community in which the Busby family lives brought in another \$160 which had been donated by the people there.

This made a total of \$500, Lindsey said, enough for the return plane fare to Oklahoma City and for reimbursement of funds the team had spent for the Olkahoma City to Gainesville flight.

Ag teacher McCormick yesterday voiced his appreciation of the "fine community spirit" which enabled the Busby boys to return to Oklahoma City.

Regardless of their showing in competition with FFA land judging teams from all over the nation-the Busby boys and their fellow team members already are big first-place winners among the people of their community.


